## STEP 1: Find Your Inspiration!

- December 10, 1869 the Wyoming Territorial Legislature granted female suffrage
- September 6, 1870, Louisa Swain of Laramie cast the first vote
- 150<sup>th</sup> Anniversary
- Wyoming is the “Equality State”
- First woman Governor sworn into a U.S. State (Nellie Tayloe Ross)
- First woman Justice of the Peace (Esther Hobart Morris)

## STEP 2: Pick Your Shape!



Circle - 1 ½” x 1 ½”



Rounded Square - 1 ½” x 1 ½”



Oval - 2” x 1”



Rounded Rectangle - 2” x 1”

- ✓ Entries must express a message related to voting *and* women suffrage.
- ✓ To ensure print quality, all designs submitted electronically should be submitted as vector files, or as high-resolution JPGs, with a minimum resolution of 300 dpi.

## "I Voted" Sticker Contest Rules

By submitting an entry, you agree to be bound by the following rules:

- 1. Eligibility:** The contest is open to students enrolled in a Wyoming high school (Junior or Senior) or a Wyoming college.
- 2. Sponsors:** The "I Voted" Sticker Contest is sponsored by the Wyoming Secretary of State's Office and Wyoming Governor's Council for Women's Suffrage Celebration. The Wyoming County Clerks will be distributing the stickers at polling places during Early Voting and on Election Day.
- 3. How to Enter:** To enter, you must complete and submit an "I Voted" Sticker Contest Entry Form. You may email your design to [elections@wyo.gov](mailto:elections@wyo.gov) or mail your entry form to:

All entries must be submitted by 5:00 p.m. on Monday, September 30, 2019. Late entries will not be accepted. In the event that a technical issue arises while submitting a contest entry, the entrant should immediately contact the Wyoming Secretary of State's Office (SOS) Election Division by phone at (307) 777-5860 or by email at [elections@wyo.gov](mailto:elections@wyo.gov).

**4. Number of Entries:** Multiple entries are permitted.

**5. Design Requirements:** Entries must express a message related to voting *and* women suffrage. The dimensions of the design should fit one of the following options:

- Circle – 1.5" x 1.5"
- Rounded Square – 1.5" x 1.5"
- Oval (horizontal) – 2" x 1"
- Rounded Rectangle (horizontal) – 2" x 1"

To ensure print quality, all designs submitted electronically should be submitted as vector files, or as high-resolution JPGs, with a minimum resolution of 300 dpi.

**6. Finalists Selection:** The Cheyenne Rotary Club will be judging the contest to narrow the entries to 10 finalists. From there, three winners will be selected by the members of the Governor's Council for the Wyoming Women's Suffrage Celebration (GC). The three finalists will then be put to a public vote through the use of Google Forms.

Entries will be judged based on the following criteria: a) Overall aesthetics or eye-catching ability; b) Strength and effectiveness of the design's message, and c) Uniqueness of the design.

The GC anticipates selecting one design for the sticker, but may accept more at its sole discretion.

**7. Contest Winner:** On or around December 1, 2019, the SOS will notify the potential winner via email and phone, using the contact information provided on the Contest Entry Form. If the potential winner cannot be verified by the SOS, the Runner Up will become the potential winner, subject to verification. Once the winner has been verified, the SOS will announce the winning design.

**8. Ownership of Entries:** The SOS and GC do not claim ownership rights to your entry or entries. By submitting the Contest Entry form and checking the box acknowledging you have read and agree to the Official Rules, you agree to grant the SOS and GC a non-exclusive, fully paid-up and royalty-free, license to use, modify, delete from, add to, publicly display, reproduce and translate your entry. By submitting an entry, you consent to the use of your design and your name in connection with the contest and all related marketing activities, in any media or format, in any and all locations, without any payment or further approval from you. You agree that nothing in these Official Rules grants you a right or license to use the SOS or GC's name.

**9. Design Rules:** By submitting an entry, you acknowledge that your entry: a) is your original work; b) does not contain references to any candidates or political parties; c) does not contain material or images that are, in the SOS and GC's sole judgement, obscene, inappropriate for a general audience that may include minors, or defamatory; d) does not violate or infringe upon the copyrights, trademarks rights of privacy, publicity or other rights of any person or entity; e) does not and will not violate any applicable law, statute, ordinance, rule or regulation; f) does not feature the likeness of a private individual without that individual's written permission for its use; and g) does not trigger any reporting or royalty obligation to any third party.

**10. Additional Terms and Conditions:** By entering the contest, each contestant agrees to: a) comply with and be bound by the Official Rules and the decisions of the SOS and GC, which are binding and final in all matters relating to this contest; b) release and hold harmless the SOS and GC and any other organizations sponsoring, advertising or promoting the contest, and all of their respective past and present officers, directors, and employees.
