## **VOTER REGISTRATION** INFORMATION

### **IT'S EASY TO REGISTER TO VOTE**

You may register and vote at your polling place on Election Day. You may also register to vote in person at the County Clerk's office or by mail not less than (14) days before an election. The voter registration application may be found on the Secretary of State's website at: http://sos.wyo.gov/Forms/Elections/General/VoterRegistrat ionForm.pdf

#### VOTER REGISTRATION REOUIREMENTS

- $\mathbf{\nabla}$ Citizen of the United States
- 18 years of age by General Election Day  $\mathbf{\nabla}$
- $\mathbf{\nabla}$ Resident of the State of Wyoming
- $\mathbf{\nabla}$ Not currently adjudicated mentally incompetent
- Not been convicted of a felony, or have had voting  $\mathbf{\nabla}$ rights restored
- Provide your Wyoming Driver's License number, or if  $\mathbf{\nabla}$ you do not have one, the last four digits of your Social Security Number and acceptable identification prescribed by Administrative Rule, Chapter 2.

#### **KEEP YOUR REGISTRATION CURRENT**

•If you did not vote in the 2022 General Election you should verify your registration with your County Clerk.

•If you moved to a different Wyoming county, you must now register in that county.

•If you have moved within your county or changed your name since the 2022 Election you must notify your County Clerk. •If you have questions about the status of your registration, contact your County Clerk.

**OUESTIONS ON REGISTERING TO VOTE** Contact your County Clerk's office. (Contact information for all 23 County Clerks is located in this pamphlet.)

### **GENERAL INFORMATION**

#### **VOTING IN-PERSON**

Voters are required to show an acceptable form of identification when voting in person or when requesting an absentee ballot in person. Any of the following will be accepted:

- WY Driver's License or ID Card
  - Wyoming Community College
    Student ID • Wyoming Public School Student ID
- Tribal ID Card • Valid US Passport Valid Medicare or Medicaid Insurance Card
- US Military Card
- DL or ID Card from Another
- State
- University of Wyoming Student ID
- · Valid Wyoming Concealed Firearm Permit

#### **VOTING ABSENTEE**

If you are a registered voter, you may request an absentee ballot at any time during the calendar year in which the election is held but not on the day of the election. Absentee voting begins, and ballots are distributed, 28 days before the election.

To request an absentee ballot, contact your County Clerk. You will need to provide your full name, residence address, mailing address, and date of birth. Remember to ensure that your absentee ballot is returned to your County Clerk's office by 7 p.m. on Election Day.

#### VOTING ASSISTANCE

Wyoming State law allows ONE person to assist a voter in the following situations: blindness, disability, or inability to read or write. This person cannot be the voter's employer, an agent of the voter's employer, or an agent or officer of the voter's union. Please contact your County Clerk with any questions about polling place accessibility.

#### **CONSTITUTIONAL AMENDMENTS**

Proposed Constitutional Amendments appear only on the General Election Ballot. In order to pass, an amendment must be approved by a majority of those voting in the General Election. Therefore, if you do not cast a vote on a proposed amendment, the result is the same as a vote against the issue.

### 2024 PROPOSED CONSTITUTIONAL AMENDMENTS

**A.** The adoption of this amendment would separate residential real property into its own class of property for purposes of property tax assessments. The amendment would authorize the legislature to create a subclass of owner occupied primary residences.

#### **DID YOU KNOW?**

Wyoming law requires that employees be given one hour off to vote on Election Day. However, there are some exceptions. The law does not apply to employees with three or more consecutive nonworking hours during the time polls are open, and some federal agencies <u>may be</u> exempt. (W.S. 22-2-111)
