The completed application must be accompanied by an **original Certificate of Evidence** of the amendment OR a **certified copy** of the amendment, dated **not more than sixty (60) days** prior to filing in Wyoming. If the amendment involves a name change, the certificate must state the previous name and the new name along with the date of the amendment.
