TO: Wyoming Independent Presidential Candidates

RE: Petition for Nomination – Placement on the General Election Ballot

Wyoming Statutes 22-5-301 through 22-5-308 are controlling legislation. The petition shall be approved by the appropriate filing office prior to circulation. The statements below are only a summary and you should consult the statutes as cited.

A petition for nomination shall be filed with the appropriate filing office. Federal or state offices file with the Secretary of State's office. Local offices file with the county clerk.

Statewide Office: Signatures Required. A petition for a statewide office shall be signed by registered electors, resident in the jurisdiction and eligible to vote for the petitioner, numbering not less than two percent (2%) of the total number of votes cast in the state for U.S. Representative in the last general election. The number of signatures required for a statewide race is **3,891** for the upcoming 2024 General Election. (W.S. 22-5-304(a))

Sworn Statements: Sworn statements by the Presidential and Vice-Presidential candidate stating their desire to be placed on the General Election ballot in Wyoming and the names of the three presidential electors shall be filed with the Office of the Secretary of State

Filing Deadline: August 26, 2024. You must file not less than seventy (70) days prior to the general election. A petition shall be circulated for signatures only during the calendar year in which the election for the office sought is to be held.

Filing Fee: \$750 – Candidates for federal offices.
