Pursuant to W.S. 6-10-106, a person convicted of a felony is incompetent to hold any office of honor, unless he has had a complete and full restoration of rights, not just voting rights. If you have any questions regarding your ability to hold office, please ask the County Clerk for clarification.

Please ensure that:

- ✓ You're not holding an office that may conflict, or be incompatible, with the office for which you are filing.
- ✓ Your employment is not incompatible with the office you are seeking.

#### GOVERNOR

- Must be at least 30 years old
- U.S. Citizen
- Qualified Elector
- Resided in the state for five years next preceding election. (Wyo. Constitution, Art. 4, Sec. 2)

#### SECRETARY OF STATE, STATE AUDITOR, STATE TREASURER AND STATE SUPERINTENDENT OF PUBLIC INSTRUCTION

- Must be at least 25 years old
- U.S. Citizen
- Qualified elector (Wyo. Constitution, Art. 4, Sec. 11)
