

STATEMENT OF CONTRIBUTIONS AND EXPENDITURES

Federal Political Action Committee

W.S. 22-25-106 through 109

This form is for **FEDERAL POLITICAL ACTION COMMITTEES (PACs)**, excluding those that contribute or expend funds only to federal candidates or for federal issues.

Who must file?

Candidates for federal office, campaign committees for candidates for federal office and federal political action committees that are making contributions or expenditures only to federal candidates or for federal issues shall not be required to file contribution and expenditure reports under this section if the candidate or the committee is required to comply with federal election law reporting requirements. W.S. 22-25-106(g)

What must be filed and when?

- A committee shall file an itemized statement of contributions and expenditures at least seven (7) days *before* the election up to the fourteenth day before the election. W.S. 22-25-106(b)(i)
- The committee shall file any amendments to a filed report within ten (10) days *after* a primary, general or special election. W.S. 22-25-106(b)(i)
- A committee formed after an election to defray campaign expenses incurred during a previous election, and any ongoing committee, shall file an itemized statement of contributions and expenditures on December 31st of each odd-numbered year and shall continue to make the reports until the committee terminates. W.S. 22-25-106(b)(ii)
- All reports required by subsection (b) of this section shall be signed by both the chairman and treasurer. The reports shall set forth the full and complete record of contributions including cash, goods or services and actual and promised expenditures. The date of each contribution of one hundred dollars (\$100.00) or more, any expenditure or obligation, the name of the person from whom received or to whom paid and the purpose of each expenditure or obligation shall be listed. Nothing in this subsection shall be construed to require the disclosure of the names of individuals paid to circulate an initiative or referendum petition. All contributions under one hundred dollars (\$100.00) shall be reported but need not be itemized. Should the accumulation of contributions from a person exceed the one hundred dollar (\$100.00) threshold, all contributions from that person shall be itemized. If the contributions, expenditures or obligations were for more than one (1) candidate, the amounts attributable to each shall be itemized separately. W.S. 22-25-106(c)

Where do I file?

- **Filing Office:** Reports shall be filed in the office specified in W.S. 22-25-107(a)(i-vii).
 - For reports to be filed with the county clerk, please visit <https://sos.wyo.gov/Elections/Docs/WYCountyClerks.pdf> for office information.
 - For reports to be filed with the secretary of state, our filing website is currently being updated and will be ready to accept Federal PAC reports by December 1st, 2023. This form is temporarily available for those who wish to file their odd-numbered year reports before those updates are finished. Completed forms shall be emailed to elections@wyo.gov. **Note: The deadline for odd-numbered year reports is December 31st.**
 - Upon completion of those updates, reports shall be filed at <https://www.wycampaignfinance.gov>.

What are the filing deadlines for the 2024 election?

- **Primary Election:** Contributions & Expenditures – 7 days before the Primary: **Aug. 6 - Aug. 13, 2024**
- **General Election:** Contributions & Expenditures – 7 days before the General: **Oct. 22 - Oct. 29, 2024**
- **Non-Election Year (odd-numbered year):** Contributions & Expenditures: **Dec. 31st**
- **Special Election:** Contributions & Expenditures – 7 days before the election

Reporting requirements:

The general rule is that a committee should note and keep track of all campaign contributions no matter how small. The law only requires you to itemize contributions on this form that total \$100 or more. However, keep in mind that if you receive \$80 from a contributor who then later gives you \$30, you must report the total \$110 contribution on this form.

Penalty for not reporting:

A person found guilty of violating Wyoming campaign finance statutes is subject to criminal charges. Failure to file a required report could result in a civil penalty of up to two hundred dollars (\$200.00) per day. W.S. 22-25-108(f).
