# Marking his first 100 Days in Office, Secretary Gray Reflects on Accomplishments Thus Far

**CHEYENNE, WY** – Marking his first 100 days in office, Secretary of State Chuck Gray reflected on all of his administration's work since January 3<sup>rd</sup>. The Secretary of State released the graphic attached below showcasing the accomplishments of Secretary Gray's administration thus far.

"Our office has already done tremendous work," Secretary Gray said. "Focusing on improving election integrity and transparency, ensuring fiscal responsibility on Constitutional and Statutory Boards, and emphasizing customer service, the Secretary of State's Office has been hard at work for the People of Wyoming."

Secretary Gray reflected on his work advocating for election integrity at the Wyoming Legislature. "On our second week in office, the 67th Legislative Session began. With a record number of bills related to elections, our administration worked diligently with the Wyoming Legislature to achieve meaningful reforms to improve election integrity in Wyoming. We achieved our number one priority of ending crossover voting through the passage of House Bill 103, which was allowed to become law in arch. HB 103 is a tremendous step forward in election integrity, which protects the sanctity of Wyoming's primary process. We also advocated for legislation which will strengthen our Voter ID Law and improve transparency in our elections. With the passage of House Bill 5, our internal policy related to the voter rolls and transparency was codified into law. Equally important, we worked to defeat legislation which has proven detrimental. In this way, I was proud to testify against the House Bill 49, which would have introduced ranked choice voting in Wyoming."

"Our work started on day one. Almost immediately after taking my oath, our office undertook an extensive review of our voter rolls and made internal changes to increase transparency, maintaining trust in our elections and preventing duplicate voting."

"On the State Loan and Investment Board, State Board of Land Commissioners, and the State Building Commission, I have worked tirelessly to ensure proper allocation of water and sewer funds to Wyoming communities. I have also worked, and will continue to work, to ensure that our investments do not consider ESG criteria, so that Wyoming may resist the woke clown show ideology which has gripped the nation."

"Lastly, we have and will continue to place an emphasis on customer satisfaction. With 68,949 new filings with our Business Division since January 1, 2023, we have and will continue to prioritize those we serve."

"I am humbled and proud to lead the Secretary of State's Office. As we look beyond our first 100 days, I am excited to continue our great work for the People of Wyoming."
