This informed our work in the 2025 Legislative Session to pass House Enrolled Act No. 62, *Maintenance of Voter Lists*, which provides statutory authority for a number of key voter list maintenance tools. In implementing HEA 62, our office has been working with both the Wyoming Department of Transportation and the United States Department of Homeland Security, United States Citizenship and Immigration Services to utilize USCIS's SAVE System for any identification of records of non-United States citizens on Wyoming's voter registry list. This program allows our office to cross-check Wyoming's voter registration records against federal immigration information as part of our continued voter list maintenance efforts to ensure only Wyoming citizens are eligible to vote in Wyoming.

In accordance with Wyoming law and our information-sharing agreement with USCIS, our office provided records to SAVE containing a robust dataset of information with which to match records on our voter registration system with federal data associated with non-United States citizens. The attached report from the SAVE System documents a known match of a voter record in your county which has been confirmed by the SAVE System as a non-citizen.

We are providing this report to you documenting grounds for cancellation in accordance with Wyoming law, as well as notice and an opportunity to provide documentary proof of United States citizenship pending the 20-day notice of cancellation. See W.S. 22-3-115 and 116. As with other cancellation notices, a voter record which is subject to cancellation due to potential non-citizen status should be placed in a "Pending" status with status reason of "Potential Non-citizen." As noted in MEMO 2025-04, if after you provide notice of intent to cancel in accordance with W.S. 22-3-115 and 116, you receive information that constitutes proof of United States citizenship, you must notify our office of the document type and any identification number associated with that document. These records must be handled in accordance with the Privacy Act of 1974.
