The completed application must be accompanied by an **original certificate of existence/good standing**, **dated** *not more than thirty (60) days* **prior** to filing in Wyoming, duly authenticated by the Secretary of State or other official having custody of corporate records in the state or country of formation.

A copy of the company resolution authorizing continuance of the statutory foundation into Wyoming.

After the continuation into Wyoming has been completed the entity will be terminated in its former jurisdiction. Evidence will be provided to this office showing that the entity has been terminated. Copies of the termination can be mailed in or emailed to business@wyo.gov.
