- ✓ **You’re not holding an office that may conflict, or be incompatible, with the office for which you are filing.**
- ✓ **Your employment is not incompatible with the office you are seeking.**

#### **UNITED STATES SENATOR**

- **Must be at least 30 years old**
- **U.S. Citizen for nine (9) years**
- **An inhabitant of the state in which he shall be chosen (U.S. Constitution, Art. 1, Sec. 2)**
- **Not claiming residency in any other state while seeking nomination**

#### **UNITED STATES HOUSE OF REPRESENTATIVES**

- **Must be at least 25 years old**
- **U.S. Citizen for seven (7) years**
- **An inhabitant of the state in which he shall be chosen. (U.S. Constitution, Art. 1, Sec. 2)**
- **Not claiming residency in any other state while seeking nomination**
